Resolution No. 21-16-13
Establish Wards, 2020 Census

WHEREAS, Wisconsin Statute Section 5.15 requires all cities, villages and towns with a population of 1,000 or more to establish wards based on the results of the 2020 census, and

WHEREAS, The 2020 Census for the Town of Pleasant Valley, Eau Claire County is 3791 and

WHEREAS, continuity is to be considered in establishing wards favoring the general boundaries established in previous division of the town into wards, and

WHEREAS, a division of the town into 5 wards following the lines of the newly established ward boundaries creating ward results in 5 wards consisting of 392 persons in ward 1, 555 persons in ward 2, 932 persons in ward 3, 916 persons in ward 4 and 996 persons in ward 5 which meets the statutory requirements for division and should be satisfactory considering possible population increases,

NOW THEREFORE BE IT RESOLVED, that the following boundaries be established for the Town of Pleasant Valley, Eau Claire County,

Ward 1: All of that portion of the Town of Pleasant Valley lying south of a line commencing at the intersection of County Road WW and the western boundary of the town, thence easterly along County Road WW to its intersection with County Road FF, thence northeasterly along County Road FF to its intersection with County Road F, thence northerly along County Road F to its intersection with W Lowes Creek Rd, thence easterly along W Lowes Creek Rd to its intersection with Lowes Creek Rd, thence southeasterly along Lowes Creek Rd to its intersection with Willow Rd, thence easterly along Willow Rd to it intersection with State Road 93, thence northerly along State Road 93 to the Northwest corner of Section 14, Township 25 North Range 09 West, thence easterly along the north line to the North Quarter corner, thence south along the north-south quarter line to the Northwest corner of the Southwest Quarter of the Northeast Quarter, thence east along the north line of said Southwest Quarter of the Northeast Quarter to the Northeast corner of said Southwest Quarter of the Northeast Quarter, thence south along the east line of said Southwest Quarter of the Northeast Quarter to the Southwest corner of the Southeast Quarter of the Northeast Quarter, thence east along the south line of said Southeast Quarter of the Northeast Quarter to the East Quarter corner of said Section 14, thence north along the west line of the Southwest Quarter of the Northwest Quarter of Section 13, Township 25 North Range 09 West to the Northwest Corner of said Southwest Quarter of the Northwest Quarter, thence east along the north line of said Southwest Quarter of the Northwest Quarter to the Northeast corner of said Southwest Quarter of the Northwest Quarter, thence south along the east line of said Southwest Quarter of the Northwest Quarter to the Southeast corner of said Southwest Quarter of the Northwest Quarter, thence east along the north line of the Northeast Quarter of the Southwest Quarter to the Northeast corner of said Northeast Quarter of the Southwest Quarter, thence south along the east line of said Northeast Quarter of the Southwest Quarter to the Southeast corner of said Northeast Quarter of the Southwest Quarter, thence east along the north line of the Southwest Quarter of the Southeast Quarter to the Northwest corner of the Southeast Quarter of the Southeast Quarter, thence along the north line of said Southeast Quarter of the Southeast Quarter to the Northeast corner of said Southeast Quarter of the Southeast Quarter, said point also being on the town boundary.

Ward 2: All of that portion of the Town of Pleasant Valley commencing at the intersection of County Road WW and the western boundary of the town, thence easterly along County Road WW to its intersection with County Road FF, thence northeasterly along County Road FF to its intersection with County Road F, thence northerly along County Road F to its intersection with W Lowes Creek Rd, thence easterly along W Lowes Creek Rd to its intersection with Lowes Creek Rd, thence southeasterly along Lowes Creek Rd to its intersection with Willow Rd, thence easterly along Willow Rd to its intersection with State Road 93, thence northerly along State Road 93 to the Northwest corner of Section 14, Township 25 North Range 09 West, thence easterly along the north line to the North Quarter corner, thence south along the north-south quarter line to the Northwest corner of the Southwest Quarter of the Northeast Quarter, thence east along the north line of said Southwest Quarter of the Northeast Quarter to the Northeast corner of said Southwest Quarter of the Northeast Quarter, thence south along the east line of said Southwest Quarter of the Northeast Quarter to the Southwest corner of the Southeast Quarter of the Northeast Quarter, thence east along the south line of said Southeast Quarter of the Northeast Quarter to the East Quarter corner of said Section 14, thence north along the west line of the Southwest Quarter of the Northwest Quarter of Section 13, Township 25 North Range 09 West to the Northwest Corner of said Southwest Quarter of the Northwest Quarter, thence east along the north line of said Southwest Quarter of the Northwest Quarter to the Northeast corner of said Southwest Quarter of the Northwest Quarter, thence south along the east line of said Southwest Quarter of the Northwest Quarter to the Southeast corner of said Southwest Quarter of the Northwest Quarter, thence east along the north line of the Northeast Quarter of the Southwest Quarter to the Northeast corner of said Northeast Quarter of the Southwest Quarter, thence south along the east line of said Northeast Quarter of the Southwest Quarter to the Southeast corner of said Northeast Quarter of the Southwest Quarter, thence east along the north line of the Southwest Quarter of the Southeast Quarter to the Northwest corner of the Southeast Quarter of the Southeast Quarter, thence along the north line of said Southeast Quarter of the Southeast Quarter to the Northeast corner of said Southeast Quarter of the Southeast Quarter, said point also being on the town boundary, thence northerly along the town boundary to its intersection with County Road V, thence westerly along County Road V to its intersection with County Road HH, thence continuing westerly along County Road HH to its intersection with the town boundary, thence south along the town boundary to the point of beginning.

Ward 3: All of that portion of the Town of Pleasant Valley commencing at the intersection of County Road HH and the western boundary of the town, thence northerly along the town boundary to the northern boundary of the town, thence easterly along the town boundary to the intersection of the town boundary and S. Lowes Creek Rd, thence southerly along S. Lowes Creek Rd to its intersection with Cedar Rd, thence easterly along Cedar Rd to its intersection with Aspen Rd, thence southeasterly along Aspen Rd to its intersection with State Road 93, thence southerly along State Road 93 to its intersection with County Road HH, thence westerly along County Road HH to the town boundary and the point of beginning.

Ward 4: All of that portion of the Town of Pleasant Valley commencing at the intersection of County Road V and the eastern boundary of the town, thence northerly along the town boundary to its intersection with Hickory Rd, thence westerly along Hickory Rd to its intersection with Michael Dr, thence southerly along Michael Dr to its intersection with Oriole Dr, thence southwesterly along Oriole Dr to its intersection with Aspen Rd, thence southeasterly along Aspen Rd to its intersection with State Road 93, thence southerly along State Road 93 to its

intersection with County Road HH, thence easterly along County Road HH to its intersection with County Road V, thence easterly along County Road V to the town boundary and the point of beginning.

Ward: 5 All of that portion of the Town of Pleasant Valley commencing at the intersection of Hickory Rd and the eastern boundary of the town, thence westerly along Hickory Rd to its intersection with Michael Dr, thence southerly along Michael Dr to its intersection with Oriole Dr, thence southwesterly along Oriole Dr to its intersection with Cedar Rd, thence westerly along Cedar Rd to its intersection with S. Lowes Creek Rd, thence northerly along S. Lowes Creek Rd to its intersection with the northern town boundary, thence following the town boundary to the point of beginning.

BE IT FURTHER RESOLVED, that the numbered census blocks included in these wards and map be made part of the resolution, and

BE IT FURTHER RESOLVED, that a copy of this resolution be transmitted to the Eau Claire County Clerk, and

BE IT FURTHER RESOLVED, that the 5 wards of the Town of Pleasant Valley will be combined for voting purposes and that the designated polls will be the Town Hall/Fire station at Cleghorn for the 5 wards, unless subsequently changed by action of the Town Board.
